COURSE SYLLABUS 2024

I. COURSE DESCRIPTION

This course is designed to equip leaders with a biblical understanding of management that will inform their thinking and transform their management practices. Learners will explore God's Word on management in four areas—theological reflections, biblical examples, practical principles, and personal applications—to prepare them to manage in a manner that reflects their Christian faith.

II. COURSE OBJECTIVES

By the end of the course, learners would have been able to:

- Summarize the four management models in Scripture and identify at least one biblicaltext for each one. (WEEK 1)
- Suggest practical ways to help those you serve become good and faithful managers forGod. (WEEK 1)
- Share biblical examples of individual managers engaged in resource mobilization andrelated to teamwork and succession and biblical examples of collective groups of managers practicing governance and accountability and managing structures and systems for scaling (WEEK 2)
- Recall the four governance councils in the Scriptures and the mindset and model that comes into view for modern application. (WEEK 2)
- Explain four biblically informed contrasting principles linked to resource management; teamwork, collaboration, and succession; governance and accountability; and legal compliance. (WEEK 3)
- Articulate the difference between the world's way of raising resources and God's designfor managers. (WEEK 3)
- Describe the four areas that biblical managers demonstrate restored relationships in their everyday management. (WEEK 4)
- Summarize the kingdom path in contrast to the common path as God's design for management to contribute to organizational and community flourishing. (WEEK 4)

III. COURSE METHODOLOGY

The methodology for this course will combine online video conference interaction, viewing videos, reading the course material /books, and responding to discussion questions online on schedule. Learners must use good time management to get work done before deadlines as part of fulfilling the educational requirements. Learners will need access to the moodle platform to watch videos, attend video conferences, and answer discussion questions.

IV. COURSE EXPECTATIONS

To optimize learning, learners are expected to:

- Participate in two video conferences to interact with the Faculty member. Read the two required readings
- Answer a total of 16 discussion questions linked to the 16 videos and course content according to the course schedule.
- Complete two one-page reflection papers linked to the two required textbooks.

In addition, Doctoral candidates are expected to:

- Read (your choice) three of the five reading from the additional articles listed below.
- Write a total of three one-page response papers that each has two sections:
 - o stating the core idea(s) you gained in each additional reading and
 - o sharing how you will apply what you learned in your context.

VII. COURSE POLICIES

Learners are required to do all their *own original work* following the guidelines for academic assignments at CIM. Each learner will seek to attain 100 marks in this coursefollowing this breakdown.

- Attend and participate on two video conference calls (6 marks each) = 12 marks
- Watch 16 videos, read related course content, and respond to 16 questions on Moodle (3 marks each) = 48 marks
- Read two books and submit one-page reflection paper for each book on schedule (20 marks each) = 40 marks

VIII. COURSE ASSESSMENT

For Non-Doctoral Candidates

Attend and participate on two video conference sessions (6 marks each) = 12 marks

- Each student that attends the two video conference sessions and actively participates willreceive six marks for each session.
- Each student that attends but does not engage in discussion will receive only three marksfor that session.
- Each student that fails to attend a video conference session will receive no marks for that session.

Watch 16 videos, read related course content, and respond to 16 questions online (3 marks each) = 48 marks

- Each learner that reports that they watched the videos, read the related Scriptures, and demonstrates this by answering each discussion question with at least 200 words with deep understanding and thoughtful engagement will receive three marks.
- Each learner that reports that they watched the videos, read the related Scriptures, and demonstrates this by answering each discussion question with less than 100-200 words that reflects emerging competence with the topic will receive two marks.
- Each learner that reports that they watched the videos, read the related Scriptures, and demonstrates this by answering each discussion question with less than 100 words that reflects knowledge of the topic will receive one mark.
- Learners that fail to respond to a discussion question will get no marks for that question.

Read two books and submit one-page reflection paper for each book on schedule (20 marks each) = 40 marks

- Each learner that reads each book on schedule gets five marks per book. A learner who reads a book late lose one mark for each day the book is late. Each learner that does not read the book on schedule will receive no marks for the book.
- Learners that submit a one-page reflection paper that says they read the book on schedule and summarizes the themes of the book, shares top two favorite quotes and two future applications will receive another up to another 15 marks per book.
- Learners that fail to share their two favorite quotes or two future applications will lose three marks for each missing item.
- Learners that do not submit a reflection paper get no marks for that book.

For Doctoral Candidates

Attend and participate on two video conference sessions (4 marks each) = 8 marks

- Each student that attends the two video conference sessions and actively participates will receive four marks for each session.
- Each student that attends but does not engage in discussion will receive only two marks for that session.
- Each student that fails to attend a video conference session will receive no marks for that session.

Watch 16 videos, read related course content, and respond to 16 questions online (2 marks each) = 32 marks

- Each learner that reports that they watched the videos, read the related Scriptures, and demonstrates this by answering each discussion question with at least 200 words with deep understanding and thoughtful engagement will receive two marks.
- Each learner that reports that they watched the videos, read the related Scriptures, and demonstrates this by answering each discussion question with less than 200 words that reflects emerging competence with the topic will receive one mark.
- Learners that fail to watch the video, read the Scriptures, and respond to a discussion question will get no marks for that question.

Read two books and submit one-page reflection paper for each book on schedule (15 marks each) = 30 marks

- Each learner that reads each book on schedule gets five marks per book. A learner who reads a book late lose one mark for each day the book is late. Each learner that does not read the book on schedule will receive no marks for the book.
- Learners that submit a one-page reflection paper that says they read the book on schedule and summarizes the themes of the book, shares top two favorite quotes and two future applications will receive another up to another 10 marks per book.
- Learners that fail to share their two favorite quotes or two future applications will lose three marks for each missing item.
- Learners that do not submit a reflection paper get no marks for that book.

Read three articles and submit one-page reflection paper for each article on schedule (10 marks each) = 30 marks

- Each learner that reads each book on schedule gets five marks per book. A learner who reads a book late lose one mark for each day the book is late. Each learner that does not read the book on schedule will receive no marks for the book.
- Learners that submit a one-page reflection paper that says they read the book on schedule and summarizes the themes of the book, shares top two favorite quotes and two future applications will receive another up to another 15 marks per book.
- Learners that fail to share their two favorite quotes or two future applications will lose three marks for each missing item.
- Learners that do not submit a reflection paper get no marks for that book
